Each year the Nelson Marlborough Rescue Helicopter service assists in over 375 missions within the region. The service operates 24 hours, 7 days a week and is free of charge to anyone who may require urgent transportation following a serious accident or illness, when it is considered

to be the appropriate means of transport, by the Ambulance Control Centre.

## What is Payroll Giving?

Payroll Giving is an easy way to support the Nelson Marlborough Rescue Helicopter Service. It is a voluntary scheme, which is administered through the Inland Revenue Department. As an employee, you can make donations directly from your pay for as little or as much as you like and for every dollar you donate, you'll receive a third back as a tax credit in the same pay period.

- It is easy to setup, you only need to take a few moments and complete one form for your regular donation to begin.
